ELECTRICITY DISTRIBUTION BYLAW AMENDMENT

Pursuant to the *Municipal Government Act*, RSA 2000, M26.1 as amended; and pursuant to the *Electric Utilities Act* RSA 2000, c. E-35, as amended, and any regulations pertaining thereto, and that these Acts and Regulation grant the Municipality certain rights and powers concerning the ownership of electrical distribution systems and their uses.

WHEREAS it is necessary to amend and update schedules to Bylaw #1649, being the Electricity Distribution Bylaw, the Council of the Town of Cardston, duly assembled, enacts as follows:

- 1) That *Electricity Distribution – Schedule “D” Regulated Rate Option Tariff – Terms and Conditions*, be replaced by *Electricity Distribution – Schedule “D” Regulated Rate Option Tariff – Terms and Conditions*, dated May 1st, 2019, effective May 1st, 2019.
- 2) That *Electricity Distribution – Schedule “E” Regulated Rate Option Tariff – Fee Schedule*, be replaced by *Electricity Distribution – Schedule “E” Regulated Rate Option Tariff – Fee Schedule*, dated May 1st, 2019, effective May 1st, 2019.
- 3) That *Electricity Distribution – Schedule “F” The Regulated Rate Option Tariff – Energy Price Setting Plan*, be replaced by *Electricity Distribution – Schedule “F” The Regulated Rate Option Tariff – Rate Schedule*, dated May 1st, 2019, effective May 1st, 2019.
- 4) That *Electricity Distribution – Schedule “G” The Default Supplier Tariff Rate Schedule, effective April 1, 2010* be replaced by *Electricity Distribution – Schedule “G” The Default Supplier Tariff Rate Schedule*, dated May 1st, 2019, effective May 1st, 2019.
- 5) That *Electricity Distribution – Schedule “H” The Default Supplier Tariff Terms and Conditions, effective October 29th, 2011* be replaced by *Electricity Distribution – Schedule “H” The Default Supplier Tariff Terms and Conditions*, dated May 1st, 2019, effective May 1st, 2019.
- 6) That *Electricity Distribution – Schedule “I” The Default Supplier Price Fee Schedule, 2011* be replaced by *Schedule “I” The Default Supplier Price Schedule Fees*, dated May 1st, 2019, effective May 1st, 2019.
