### Residential

This rate schedule is for the provision of electricity services in accordance with the *Rate of Last Resort Regulation* (AR 262/2005) and the *Electric Utilities Act*, S.A. 2003, c. E-5.1.

#### Applicability

1. This rate applies to “rate classification customers” as defined by the *Rate of Last Resort Regulation* (AR 262/2005).
2. This rate applies to all residential customers which obtain Residential Service pursuant to the Town of Cardston Distribution Tariff.

## TOWN OF CARDSTON REGULATED RATE TARIFF

### Small Commercial

This rate schedule is for the provision of electricity services in accordance with the *Rate of Last Resort Regulation* (AR 262/2005) and the *Electric Utilities Act*, S.A. 2003, c. E-5.1.

#### Applicability

1. Commercial Customers are eligible for this rate if a reasonable forecast of the customer's annual consumption of electric energy at a site is less than 250 MWh.
2. This rate applies to all commercial customers which obtain Small Commercial (Commercial/Industrial Service <50 kVA) Service pursuant to the Town of Cardston Distribution Tariff.

# BYLAW 1649

## TOWN OF CARDSTON REGULATED RATE TARIFF

### Medium Commercial

This rate schedule is for the provision of electricity services by ENMAX Energy Corporation on behalf of the Town of Cardston in accordance with the Regulated Rate Option Regulation (AR 262/2005) and the Electric Utilities Act, S.A. 2003, c.E-5.1.

#### Eligibility

1. Commercial customers are eligible for this rate if a reasonable forecast of the customer's annual consumption of electric energy at a Site is less than 250 MWh.
2. This rate applies to all commercial customers eligible for CRD400 distribution service pursuant to the Town of Cardston Distribution Tariff.

#### Rate

Energy Charge:	Rate of Last Resort* \$/kWh
Administration Charge:	0.2562 \$/day
Transmission Charges:	Per Distribution Tariff
Distribution Charges:	Per Distribution Tariff

#### Local Access Fee (LAF)

The LAF is a surcharge imposed by the Town of Cardston and is not approved by the Alberta Utilities Commission. The LAF is applicable to all services located within the Town of Cardston.
